Part A: Pupil premium strategy plan

Statement of intent

At All Saints CE Primary School, we believe that the highest possible standards can only be achieved by having the highest expectations of all learners. Some pupils from disadvantaged backgrounds require additional support; therefore, we will use all the resources available to help them reach their full potential, including the pupil premium grant (PPG). Our school's distinctively Christian ethos, 'Do everything in love' (1 Corinthians 16:14) is rooted in our belief that every child is unique and that this is reflected in the desire, commitment and aspirations of our school staff to address and overcome all barriers to learning that may hinder pupil progress and attainment, and ultimately affect their opportunities in life. When our children begin the All Saints journey. and especially in the aftermath of Covid 19, they often have previous traumatic experiences ACE's (Adverse Childhood Experiences), repeated negative educational encounters, physical and psychological trauma and complex diagnosed and undiagnosed conditions that result in children lacking the neurological development required for concentration and learning. This has major implications for confidence and self-esteem, along with the desire and inspiration to achieve, so we use the PPG to provide a wide range of additional opportunities to increase safety and trust for investment for lifelong aspirations for all and raise expectations and achievements for all children.

Challenges

Whilst not yet at national, outcomes across the school are rising at a more rapid rate than seen nationally and this is more apparent in the lower part of the school upwards with phonics and KS1 outcomes rising rapidly and KS1 in particular nudging close to national. At KS2 outcomes are harder to shift due to legacy of previously inconsistent practice coupled with the impact of the pandemic

Weekly staff CPD sessions focus on pedagogy and an instructional coaching model with a strong focus on consistent delivery of evidence based approaches, pre teaching/ interventions etc and coupled with a more clearly sequenced curriculum is showing impact albeit in small steps of progress. All TA timetables are focussed on meeting the needs through quality first teaching and

closing the attainment gap for our PPG children and there are more effective and rigorous interventions in place. Improved staff attendance is also having a positive impact.

We have seen improvements in attendance and punctuality especially due to the walking bus and breakfast provision. The rates of suspension have declined and no PPG children have been suspended.

The school has a renewed leadership structure and permanent staffing in place and this coupled with refinements to delivery and implementation of the curriculum. Clearly targeted one to one / small group additional tuition by skilled teaching staff in addition to QfT as well as new ways of deploying support staff to deliver interventions on a much more targeted basis is leading to improved outcomes for ALL children but particular PPG.
